On October 20, 2022, Deputy Jordan Roebuck was dispatched to 159 Mountain Top Estate Road, Graham, TX in reference to a cow being on the reporting partys property. The reporting party in this incident has been identified as Marie Moore.

Deputy Roebuck arrived and observed a yellow in color Jersey Cow that had cut off horns and branded with the letter "D" with a bar underneath. Deputy Roebuck asked dispatch to assist in finding an owner and after making contact with several landowners in the area, dispatch advised that they were unable to locate any information on a possible owner.

Deputy Roebuck attempted to locate an owner by knocking on several residences in the area and showing a photo of the cow to the residents. Deputy Roebuck was unable to locate an owner. Deputy Roebuck then contacted the Sheriff's Office contracted cowboy, Mr. Gabe Pratt, who stated he was already in the area attempting to locate the same cow after being notified by residents in the area that the yellow cow was damaging property in the area.

Deputy Roebuck and Mr. Pratt impounded the cow as an owner was not able to be located after many reasonable attempts to do so. The cow was photographed and transported to the Sale Barn located at 203 TX-67 in Graham, TX where it will be secured until an owner claims it or 18 days have passed.
