ITEM NO. 1 - Call to order - All stand if convenient.

THEN, County Judge, John C. Bullock, called the meeting to order and made note that all commissioners were present and that the meeting had been posted in the manner and for the time required.

ITEM NO. 2 - Invocation, followed by the U.S. Pledge and Texas Pledge (Honor the Texas flag, I pledge allegiance to thee, Texas, One state under God, One and Indivisible).

NEXT, Commissioner Stacey K. Rogers offered the Invocation, followed by the U.S. Pledge and Texas Pledge.

ITEM NO. 3 – Consider and take action on re-adoption of Resolution to be become eligible to participate in Tax Abatement including Guidelines and Criteria

Survey No. 2057, A-1076 and All of the S. Barrick Survey, A-1975, being the same land conveyed by deed dated January 27, 1989, Volume 731, Page 377, Deed Records of Young County, Texas, from Eddie N. McCluskey to Morris Stephens.
