However, state law requires that a public hearing be held by governing body before a budget may be adopted or a vote may be taken on the proposed tax rate.

A hearing to formally adopt the budget and set the tax rates for maintenance and operation and for debt service has been set in the manner and time as required by Truth-in-Taxation, Texas Government Code, Chapter 26 and Local Government Code, Chapter 111, for August 24, 2020 @9:30 AM in the Young County Courtroom, Room 106, Graham, Texas.

Announcement calculation of the Tax Rates for Young County, Texas, were completed August 7, 2020, as follows:

No-New-Revenue Rate .646085 Voter Approval Rate .789687 Debt Rate .041847
