ITEM NO. 1 – Call to order – All stand if convenient

THEN, County Judge, John C. Bullock, called the meeting to order and made note that all Commissioners were present and that the meeting had been posted in the manor and for the time required

NEXT, Commissioner Jimmy Wiley made a motion to approve Budget Amendments for the County Clerk Office Equipment of \$1287.00 from Contingency; Tax Assessor Collection Other Equipment for \$1,884.00 from Contingency and Justice of the Peace #3 for \$867.00 Other Equipment from Contingency; outlined in Exhibit "E". Motion was seconded by Commissioner Matt Pruitt and carried 5-0.
