THEN, Commissioner Jimmy Wiley made a motion to approve ordering Cell Locking System for the Young County Jail to replace three computers used for control, two control computers with software and one ADS admin domain station, logger, history reporter, remote support computer for \$16,370.00 and will discuss at the next Commissioner's Meeting of where the funds will come from either Jail Development or ARPA funds; outlined in Exhibit "G". Motion was seconded by County Judge John C. Bullock and carried 5-0.
