ITEM NO. 11.Discuss / Consider findings of the Young County Historical Commission regarding the county-owned cemetery known as the "William P. Johnston Cemetery".

- Im Hammond, Chairman of the Young County Historical Commission, provided a report on the history of the William P. Johnston Cemetery. The report included an overview of the cemetery's history and its significance to the local community. The report noted that the cemetery has operated without an official name and has been referred to by various names, many of which include language that is now considered racist and divisive. The Young County Historical Ccommission emphasized the importance of continued support for the preservation of this historically significant landmark and recommended that the cemetery be given the official name of William P. Johnston Cemetery, which is the name it has been commonly referred to for the last 55 years. He also noted that members of the Cemetery Preservation Board, who all attended the meeting, have done their independent research and came to the same conclusions.

ITEM NO. 12. Discuss / Consider: Resolution #121 - FY2025: A resolution of the Young County Commissioners Court officially naming the County Cemetery located on the 380 bypass in Graham, Texas as "William P. Johnston Cemetery".

- Summary: During the discussion, one non-county resident proposed alternative names for the cemetery. Several county residents and descendants of relatives interned in the cemetery expressed support for the name William P. Johnston Cemetery and opposed the use of names that carry racist connotations. The majority of the discussions focused on t
- The impact William P. Johnston had on the cemetery, the appropriateness of honoring his legacy, and is
- Input from local historians and community members about the cemetery's role in county history.

NEXT, Commissioner Stacy Creswell made a motion to approve the "William P. Johnston Cemetery" as the official name, Motion was seconded by Commissioner Scott Shook and carried 5-0. /EXHIBIT "I"/

 the regulations is to preserve the dignity of the site while ensuring clarity for future use and
 management.

 expenditures, and the resulting operational deficit for the reporting period.
- Per the terms of the current Lease Agreement between the Young County Commissioners' Court and the City of Graham, the County is obligated to provide financial support to cover operational shortfalls at the YCA.
- The reported operational deficit for Q2 FY2025 is \$23,673.53. This item seeks the Court's
 approval to authorize the disbursement of this amount to the City of Graham in accordance with
 the lease terms.
