### ITEM NO. 1 - Call to order - All stand if convenient.

THEN, County Judge, John C. Bullock, called the meeting to order and made note that all commissioners were present and that the meeting had been posted in the manor and for the time required.

Lauren Sullivan, Election Administrator, presented to the court that 4600 voters voted in this last election and 450 completed a survey.

Kari Burton, election Judge from Loving, spoke to Commissioners Court and was excited about the Poll Voting Places.

County Judge, John C. Bullock, announced to the Court that he would need to send a letter to the Secretary of State on the polling places and that the polling places were successful.

Commissioner Jimmy Wiley spoke on voters not always knowing where to vote – this will help in that situation. Commissioner Jimmy Wiley also stressed about early voting.
