ITEM NO. 1 – Call to order – Announcement of calculated Tax Rates and combined Rate proposed for Adoption Monday, August 24, 2015, at 9:30 A.M., 516 4th Street, Room 106, Graham, Texas.

THEN, County Judge John C. Bullock called the meeting to order and noted all commissioners were present and the meeting had been posted in the manor and for the time required.

ITEM NO. 2 “ 1ST Public Hearing on Proposed Tax Increase” As required by Truth-In-Taxation

A tax rate of \$.568700 per \$100 valuation has been proposed for adoption by the governing body of Young County Local Government. This rate exceeds the lower of the effective or rollback tax rate, and state law requires that two public hearings be held by the governing body before adopting the proposed tax rate. A hearing to formally adopt the budget and set the tax rates for maintenance and operations and for debt service has been set for Monday, August 24, 2015 @ 9:30 AM in the Young County Courtroom @ 516 Fourth Street, Room 106, Graham, Texas 76450. **NOTE: NO PUBLIC ATTENDANCE IN COURTROOM**

NEXT, County Judge John C. Bullock opened the court for the 1st Public Hearing on tax that exceeds the lower of the effective or rollback tax rate, outlined in Exhibit “A”. County Judge, John C. Bullock moved to close the public hearing. Motion was seconded by Commissioner Stacey K. Rogers and carried 5-0.

ITEM NO. 3 – Re-announce 2nd Public Hearing to be held Monday, August 17, 2015, 516 4th Street, Room 106, Graham, Texas @ 9:30 AM and the Budget Adopting Hearing scheduled for August 24, 2015 @ 9:30 A.M., 516 4th Street, Room 106, Graham, Texas.


THEN, County Judge, John C. Bullock moved to close the public hearing. Motion was seconded by Commissioner Stacey K. Rogers and carried 5-0.

ITEM NO. 4 - Adjourn/Recess


THEN, County Judge, John C. Bullock moved to adjourn meeting. Motion was seconded by Commissioner Stacey K. Rogers and carried 5-0.
