Rogers moved to execute the by-back option on a 2014 140M2 Cat Motor Grader with Warren Cat at a trade in allowance of \$214,500.00 and to purchase a 2018 140M3 Cat Motor Grader for a Purchase Price of \$277,500.00 leaving a balance of \$63,000.00 to be paid for upon delivery; outlined in Exhibit "P". Motion was seconded by Commissioner Jimmy Wiley and carried 5-0.

NEXT, Commissioner Stacey K. Rogers moved to trade a 2015 Cat 120M2 Motor Grader with a trade in allowance of \$165,500.00 for a 2018 120 M2 Cat Motor Grader with a Purchase Price of \$204,450.00 with Warren Cat through Buy Board leaving a balance of

\$38,950.00 to be paid upon delivery; outline in Exhibit "Q". Motion was seconded by Commissioner Jimmy Wiley and carried 5-0.

THEN, Commissioner Matt Pruitt moved to authorize the purchase of a 2018 140M3 Motor Grader in the amount of \$277,500.00 less money received from Howard McAnear Equipment, Ft Worth on the 2015 140M3 of \$229,324.00 as down payment leaving a balance due of \$48,176.00 to be financed through First National Leasing, Stewart Cobb with a 2.9 percent interest; outlined in Exhibit "R". Motion was seconded by Commissioner Jimmy Wiley and carried 5-0.

NEXT, Commissioner Matt Pruitt moved to execute the buy-back option on a 2014 140M Motor Grader in the amount of \$216,000.00 and the purchase of a 2018 140 M3 Cat Motor Grader in the amount of \$277,500.00 with Warren Cat through Buy Board leaving a balance due of \$61,500.00 to be finance through First National Leasing, Stewart Cobb with a 2.9 percent interest; outlined in Exhibit "S". Motion was seconded by Commissioner Jimmy Wiley and carried 5-0.


