ITEM NO. 1 - Call to order - All stand if convenient.

THEN, County Judge, John C. Bullock, **called** the meeting to order and made note that all commissioners were present and that the meeting had been posted in the manner and for the time required.

THEN, Commissioner Jimmy Wiley made a motion to adopt the Tax Rate for debt service; outlined in Exhibit "C". Motion was seconded by Commissioner Matt Pruitt and carried 4-1 (Commissioner Stacey K. Rogers)

• Then, Commissioner Matt Pruitt moved to adopt a rate of .672931 per \$100.00 value for Maintenance and Operations. Motion seconded by Commissioner Sipes and passed 3-2 (Judge Bullock and Commissioner Rogers opposing)
