**ITEM NO. 1 – Call to order – Announcement of calculated Tax Rates and combined Rate proposed for Adoption Monday, August 29, 2016, 9:30 a.m. 516 4<sup>th</sup> Street, Room 106, Graham, Texas.**

**ITEM NO. 2                                   “1<sup>st</sup> Public Hearing on Proposed Tax Increase”  
As Required by Truth-In-Taxation**

**A tax rate of \$.747570 per \$100 valuation has been proposed for adoption by the governing body of Young County. This tax rate exceeds the lower of the effective or rollback tax rate and state law requires that two public hearings be held by the governing body before adopting the proposed tax rate. A hearing to formally adopt the budget and set the tax rate for maintenance and operations and for debt service has been set for Monday, August 29, 2016 @ 9:30 a.m. in the Young County Courtroom @ 516 Fourth Street, Room 106, Graham, Texas. NOTE: NO PUBLIC ATTENDANCE IN COURTROOM**

County Judge John C. Bullock opened the court for the 1<sup>st</sup> Public Hearing on tax that exceeds the lower of the effective or rollback tax rate. There being no members of the public in attendance and such hearing held open for approximately 20 minutes and no comments received.


**NEXT**, Commissioner Matt Pruitt moved to close the public hearing. Motion was seconded by Commissioner Mike Sipes and carried 4-0.
