#### ITEM NO. 1 - Call to order - All stand if convenient.

THEN, County Judge John C. Bullock called the meeting to order, all of the court was present, the meeting had been posted in the manor and for time required.

ITEM NO. 2 – Invocation, followed by the U.S. Pledge (Honor the Texas flag, I pledge allegiance to thee, Texas, One state under God, One and Indivisible)

**NEXT**, Commissioner Jimmy Wiley offered the Invocation, followed by the U.S. Pledge and Texas Pledge.

ITEM NO. 3 - 9:30 A.M. Public Hearing - Consider Adoption of FY2017 for Young County, Texas.

- Consider FY2017 Budget
- Consider Adoption of Tax Rate.

A. Debt Service Rate .087538
B. Maintenance & Operation Rate .654091

Total Tax Rate .741629

County Judge John C. Bullock opened the floor for Public Hearing to consider the FY2017 Budget, after notice duly given in the manor and for the time required and subsequent to public hearing as prescribed by law, and then invited members of the public to come forward and express their views or County Commissioner's to express their views. Note: the original public hearing was set for August 29, 2016. No Public Attendance

After no comment from the public on the proposed tax increase, Commissioner Mike Sipes moved to adopt the budget of Young County, Texas with a total of \$12,170,185.00, outlined in Exhibit "A", as presented this the 12th day of September, 2016 and to become effective upon October 1, 2016 for the FY 2017 Budget Year. Motion was seconded by Commissioner Matt Pruitt and carried 3-2, with Judge Bullock and Commissioner Stacey Rogers with opposition. This budget will require raising more revenue from property taxes than in the previous year.

Therefore, Commissioner Matt Pruitt moved to ratify the property tax increase as reflected in the FY2017 Adopted Budget of Young County, Teas, set out in Exhibit "B". Motion was seconded by Commissioner Jimmy Wiley and carried 3-2, with County Judge John Bullock and Commissioner Stacey K. Rogers with opposition.

Pursuant to 26.05 of the Texas Tax Code, County Judge John C. Bullock moved that Young County Commissioner Court set the Debt Service Rate for the Tax Year 2017 at .087538 per \$100.00 value; outlined in Exhibit "C". Motion was seconded by Commissioner Mike Sipes and carried 5-0, with no opposition.

Commissioner Jimmy Wiley then moved that the Property Tax Rate for Maintenance and Operation of, be set at .654091 per \$100.00 value. Motion was seconded by Commissioner Matt Pruitt and carried 5-0, with no opposition.

"THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENACE AND OPERATIONS THAT LAST YEARS RATE AND THE TAX RATE WILL EFFECTIVELY BE RAISED BY .191 OR 19 %.

With no further action or comment by the public, Commission Jimmy Wiley moved to close the public hearing. Motion was seconded by Commissioner Matt Pruitt and carried 5-0, with no opposition.
