
Time of Sale: The earliest time at which the sale will occur is 10:00 a.m., Graham, Texas local time, and shall begin not later than 3 hours thereafter.

BEING the SURFACE AND SURFACE ESTATE ONLY in and to a tract of land containing 177.17 acres, more or less, in the W. T. Compere Survey, Abstract No. 1719, the W. T. Compere Survey, Abstract No. 1954, the S. M. Wann Survey, Abstract No. 1714 and the G. B. & N. Co. Survey No. 4, Abstract No. 119, Young County, Texas and being the same tracts conveyed to Roy Patterson recorded in Volume 822, Page 700 and Volume 841, Page 748, Deed Records of Young County, Texas. Said 177.17 acre tract being more particularly described as follows:

BEGINNING at a 5/8 inch iron rod found at an ell corner of the said Patterson Tracts and a northwest corner of the HTH Land, Ltd. Tract recorded in Volume 876, Page 404, Deed Records of Young County, Texas, called to be the northeast corner of the said Compere Survey, Abstract No. 1954;

THENCE South 01 degrees 00 minutes 39 seconds West for a distance of 489.32 feet to a 5/8 inch iron rod found at the base of a fence corner being the most southerly southeast corner of the said Patterson Tracts and the northeast corner of the Russell Garvey Tract recorded in Volume 797, Page 872, Deed Records of Young County, Texas;

THENCE South 89 degrees 59 minutes 58 seconds West for a distance of 3414.04 feet to a 5/8 inch iron rod found at the base of a fence corner on the east line of Texas Farm Road No. 2652 (100 foot wide highway) being the southwest corner of the said Patterson Tracts and the northwest corner of the said Garvey Tract;

THENCE North 13 degrees 02 minutes 34 seconds East for a distance of 226.23 feet to a 5/8 inch iron rod found at a point of curvature on the east line of the said highway;
