

Notice Pursuant to *Texas Local Government Code* Section 152.013 Regarding a proposal by Young County Commissioners Court to Increase Salaries, Expenses and Allowances of Elected County and Precinct Officers for Fiscal Year 2013 (October 1, 2012 - September 30, 2013)

In accordance with Texas Local Government Code Section 152.013(b), the Young County Commissioners Court gives notice that the Young County Commissioners Court will hold a public hearing to set the salaries, expenses and other allowances of elected county and precinct officers of Young County for Fiscal Year 2013. The hearing will be held in the **County Courtroom, Room 106, Young County Courthouse, 516 Fourth Street, Graham, Young County, Texas on Monday, August 13, 2012 at 9:30 a.m.** At the conclusion of the public hearing, the Commissioners Court will set the salaries, expenses and/or allowances for elected county and precinct officers for Fiscal Year 2013. The current salaries and allowances of such officers are set forth below, together with the amounts of the proposed increases.
